# Summary of findings

## Overall summary

HF Trust -117 a & b Hitchin Road is a residential service registered to provide accommodation and nursing or personal care to up to 11 people, who have a learning disability and associated needs. At the time of our inspection the home was fully occupied.

We found the following examples of good practice.

- ☐ There was a robust visiting management procedure in place to ensure people living at the service were kept safe.
- ☐ The provider adhered to COVID-19 testing regime in line with the government guidance. A designated member of staff had been employed by the provider to monitor and log all staff and residents' test results across all the locations in the region.
- ☐ People continued to be supported to safely access local facilities such as parks, shops and cinema, in line with COVID-19 guidance.
- ☐ Staff had access to sufficient supplies of personal protective equipment and had been trained in using it correctly.

## **Detailed findings**

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at how services manage infection control and visiting arrangements. This was a targeted inspection looking at the infection prevention and control measures the provider had in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 25 January 2022 and was announced. We gave the service one day's notice of the inspection.

# Is the service safe?

## Our findings

### Staffing

- The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures.

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- We were assured the provider was facilitating visits for people living in the home in accordance with the current guidance.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

- The service was meeting the requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
