# Summary of findings

## Overall summary

Cranwell Court is a 'care home'. It provides care and support for up to seven people living with learning disabilities or autistic spectrum conditions. At the time of inspection four people were living at this service.

We found the following examples of good practice.

- Staff were provided with designated areas for their arrival at and departure from the service, where Personal Protective Equipment (PPE) was available and hand sanitiser provided. Staff were seen to be maintaining social distance and adhering to the PPE guidance and protective measures in place.
- The service had been providing 'garden visits' with robust infection control procedures in place. Visits were limited and were by appointment only, with times allocated to avoid potential infection transmission with other visitors.
- Procedures and guidance had been developed by the registered manager which had been successfully implemented at the service. All COVID-19 related risks were assessed and staff in high risk groups, including those returning to work following shielding, had individual risk assessments in place.
- People's wellbeing had been prioritised. Staff had put in place strategies for managing people's anxieties in relation to COVID-19.

## **Detailed findings**

### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the coronavirus pandemic we are conducting a thematic review of infection control and prevention measures in care homes.

The service was selected to take part in this thematic review which is seeking to identify examples of good practice in infection prevention and control.

This inspection took place on 20 November 2020 and was announced.
