## Summary of findings

### Overall summary

Bargery Road is a care home that provides care and support for people with learning disabilities and autistic people. At the time of the inspection there were four people using the service.

We found the following examples of good practice.

The provider had adapted the visitors' protocol as government guidelines changed. Visitors were asked to complete a COVID-19 test, wear appropriate [personal protective equipment] PPE and follow hand hygiene procedures before entering the service.

The provider supported people to adhere to self-isolation guidelines when they had a positive COVID-19 test result. The provider had plans in place to ensure people could continue to access their local community safely during the pandemic.

The provider ensured there was an adequate supply of PPE and staff received ongoing infection control and prevention training. The registered manager made regular checks to ensure staff continued to use PPE appropriately.

The service was taking part in regular COVID-19 testing for people and staff in line with current government guidance.

The service was kept clean and hygienic. There were regular checks and audits of the service to ensure high standards of hygiene were maintained.

The provider had developed a range of risk assessments and contingency plans to mitigate the risks associated with the pandemic.

**Detailed findings** 

### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at how services manage infection control and visiting arrangements. This was a targeted inspection looking at the infection prevention and control measures the provider had in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 17 February 2022 and was announced. We gave the service 24 hours notice of the inspection.

### Our findings

#### Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.
- We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.
- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- We were assured the provider was facilitating visits for people living in the home in accordance with the current guidance.
- We were somewhat assured that the provider was admitting people safely to the service. We have advised the provider to update their admissions policy in line with current guidance.
- From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency. We checked to make sure the service was meeting this requirement.
- The Government has announced its intention to change the legal requirement for vaccination in care homes. At the time of the inspection we found the service did not have effective measures in place to ensure this requirement was being met as there were not always records kept of the vaccination status of visiting professionals. We raised this with the provider, and they have updated their procedure to ensure staff record the vaccination status of all eligible people entering the care home.
