Summary of findings

Overall summary

Newton Hall is a residential care home providing accommodation and personal care to 31 people aged 65 and over at the time of the inspection. The service can support up to 34 people.

We found the following examples of good practice.

The provider had developed detailed policies and procedures to manage any risks relating to the COVID-19 pandemic. These were clear to follow and regularly updated.

Systems were in place to screen visitors for symptoms of COVID-19. Relatives spoke highly of the care provided at Newton Hall, describing staff as 'absolutely fantastic'. People receiving care also spoke positively about the care they received and told us they were happy.

Staff wore appropriate personal protective equipment (PPE) and had access to adequate supplies. People receiving care and relatives also confirmed staff wore PPE. Signage and information was prominently displayed. Posters were often styled as vintage posters which made the environment feel homely.

People living at the service and staff members had access to regular COVID-19 testing.

The registered manager had appointed infection control leads. Their role was to undertake daily health checks on staff and to share any changes in local or national guidance with their colleagues.

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to the COVID-19 pandemic we are looking at the preparedness of care homes in relation to infection prevention and control. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.

This inspection took place on 19 March 2021 and was announced.
