Summary of findings

Overall summary

Ashby Lodge Residential Home provides accommodation and personal care for up to 22 adults, some of whom are living with dementia. There were 19 people residing at Ashby Lodge on the day of this inspection.

We found the following examples of good practice.

There were measures in place to prevent any visitors from spreading infection at the entrance and on entering the premises. These included supplies of PPE and hand sanitisers throughout the building.

The provider had utilised the space available to facilitate safe visiting and to improve people's well-being when having to isolate. For example, a previously under used lounge with it's own outdoor entrance was used by visiting friends and family.

The home was clean. Enhanced cleaning schedules were in place.

People living at Ashby Lodge Residential Home and staff were tested regularly in line with government guidance. People were supported to self-isolate as appropriate.

Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

As part of CQC's response to care homes with outbreaks of COVID-19, we are conducting reviews to ensure that the Infection Prevention and Control (IPC) practice is safe and that services are compliant with IPC measures. This was a targeted inspection looking at the IPC practices the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service.

This inspection took place on 27 January 2022 and was announced. We gave the service 24 hours' notice of the inspection.

Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures.

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.

- We were assured that the provider was admitting people safely to the service.

- We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.
- We were assured that the provider's infection prevention and control policy was up to date.
- Visiting was taking place in accordance with the current government guidance.

Visiting in care homes
