## Summary of findings

#### Overall summary

Queen Elizabeth Park is a nursing home providing support to a maximum of 77 older people. People living at the service had physical disabilities, long term medical conditions and many people were living with dementia. Care was provided across three floors in a purpose-built building. At the time of inspection there were 58 people living at the service.

We found the following examples of good practice.

Staff were observed to use personal protective equipment (PPE) within national guidance. Staff spoken with were knowledgeable and able to talk about safe PPE use.

Staff had been supported with additional training for infection, prevention and control alongside personal protective equipment. This enabled staff members to take on some responsibility within the home to cascade additional learning and support to their colleagues.

The provider had completed comprehensive risk assessments around Covid-19. This included looking at the management of the vaccine being administered to people, potential side effects and any anxieties regarding receiving the vaccine.

The registered manager had maintained a strong relationship with other healthcare professionals throughout the pandemic. The GP who provided support for the service provided positive feedback around the service being responsive and seeking advice and support in a timely manner for people.

**Detailed findings** 

#### Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

We received information of concern about infection control and prevention measures at this service. This was a targeted inspection looking at the infection control and prevention measures the provider has in place.

This inspection took place on 04 February 2021 and was announced.
