Summary of findings

Overall summary

Huntingdon Court is a care home providing accommodation and personal care for up to 43 people aged 65 and over who may also be living with dementia. At the time of the inspection twenty-three people were using the service. Accommodation is provided over the ground and first floor with communal lounges and dining areas.

We found the following examples of good practice

• An isolation lounge had been created to support a person at risk of falling so they could remain safe, feel less isolated and could be monitored by staff.

• Communication between managers, people, staff and families was good. Changes were quickly communicated so that people knew and understood the correct guidance to follow to reduce the risk of spreading any infections.

• Cleaning schedules and checklists were in use to make sure the premises and equipment were clean and any high touch areas were cleaned at least four times in every 24 hours.

Huntingdon Court Detailed findings

Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008. We received information of concern about infection prevention and control measures at this service. This was a targeted inspection looking at the infection prevention and control measures the provider has in place. We also asked the provider about any staffing pressures the service was experiencing and whether this was having an impact on the service. This inspection took place on 13 January 2022 and was unannounced.

Our findings

Staffing

• The provider told us they had measures in place to mitigate the risks associated with COVID-19 related staff pressures

How well are people protected by the prevention and control of infection?

- We were assured that the provider was preventing visitors from catching and spreading infections.
- We were assured that the provider was meeting shielding and social distancing rules.
- We were assured that the provider was admitting people safely to the service.
- We were assured that the provider was using PPE effectively and safely.
- We were assured that the provider was accessing testing for people using the service and staff.

• We were assured that the provider was promoting safety through the layout and hygiene practices of the premises.

• We were assured that the provider was making sure infection outbreaks can be effectively prevented or managed.

• We were assured that the provider's infection prevention and control policy was up to date.

• We were assured the provider was facilitating visits for people living in the home in accordance with the current guidance.

From 11 November 2021 registered persons must make sure all care home workers and other professionals visiting the service are fully vaccinated against COVID-19, unless they have an exemption or there is an emergency.

• The service was meeting the requirement to ensure non-exempt staff and visiting professionals were vaccinated against COVID-19.
