## Summary of findings

### Overall summary

We found the following examples of good practice.

We were assured that this service met good infection prevention and control guidelines as a designated care setting.

- The designated setting is a separate self-contained unit within the home with nine single bedrooms, its own communal areas, outdoor space and toilet and bathroom facilities. It has recently been refurbished to a high standard and is ready for use.
- Refurbishment is ongoing in other parts of the home. The provider has given assurance that the designated setting will not be used until the refurbishment programme is completed.
- The home is currently closed to non-essential visitors due to local lockdown restrictions. People are supported to keep in touch with family and friends through regular telephone and video calls.

## Background to this inspection

We carried out this inspection under Section 60 of the Health and Social Care Act 2008 as part of our regulatory functions. This inspection was planned to check whether the provider is meeting the legal requirements and regulations associated with the Health and Social Care Act 2008.

This was a targeted inspection looking at the infection control and prevention measures the provider has in place. As part of CQC's response to the coronavirus pandemic we are conducting a review of infection control and prevention measures in care homes.

The service had been identified for use by the Local Authority as a designated care setting in response to the Winter Plan for people discharged from hospital with a positive Covid-19 status. This inspection was to ensure that the service was compliant with infection control and prevention measures.

This inspection took place on 20 October 2020 and was announced.
